Individual Membership Application

About MCSN

The Musical Copyright Society Nigeria (MCSN) exists to collect and distribute Performance, Mechanical, and Neighboring rights royalties on behalf of its members (songwriters, composers, performers, producers, record labels, and music publishers) and on behalf of members of the international overseas societies that are affiliated to us.

Music users such as broadcasters, venues and businesses must pay for their use of copyright music by way of a licence fee. MCSN collects these monies and distributes them to the copyright owners involved.

Are you eligible for Membership?

Eligible members must be Nigerian songwriters, performers, producers, composers or lyricists, or those music creators that have taken up permanent residency in Nigeria, who meet one of the following criteria and have proof of performance:

- Your music has been published by a music publisher;
- Your music has been released on a commercial recording (available for sale); or
- Your music has been, or will be, performed in a public forum (radio, TV, live) subject to licensing by MCSN.

Eligible publishers will be accepted for membership if they can establish that they have an office in Nigeria and that, by contract, they have been assigned one of the following:

- At least five musical works written or co-written by an MCSN member or a Nigerian who is a member of another CMO;
- At least one musical work written or co-written by an MCSN member or a Nigerian who is a member of another CMO featured on a commercial recording; or
- At least one musical cue listed on an audio-visual cue sheet written or co-written by a MCSN member or a Nigerian who is a member of another CMO.

How do I Apply?

In order to apply for MCSN membership, you must fill in the attached Application Form/Member Agreement and return your completed document to MCSN, along with the other documents listed below.

The Member Agreement (which includes an assignment of specific rights in your copyright works to MCSN) will take effect only if MCSN accepts your application for membership. If you are in doubt as to the effect of the Member Agreement you are advised to obtain legal advice before signing it.

Notes for Completing Member Application

- **Legal Name:** This is your name as it appears on your birth certificate. We require your middle names to eliminate confusion with any other member who may have a similar name to you.
- Pseudonyms, stage names or professional names: This section is NOT for your band name but for any name that you, as an individual, might perform under.
- Band Name or name of Performing Group: If you perform with more than one group, please name all groups.
- Membership Category: Select the applicable Category;

Composer: Someone who creates original Musical compositions, melodies, harmonies, and arrangements.

Songwriter: Someone who crafts lyrics and melodies for songs.

Performer: Someone who executes and interprets through live or recorded performances.

Producer: Someone who oversees the recording, mixing, and production of musical tracks.

- Contact Details: Please ensure that you include at least a postal address, mobile number and email address. Also include your Nationality (The country you claim), Residence (The country you currently live in), Country of Birth (The country you were born in), Place of origin (The place you originate from), Place of Birth (The place or state you were born in), Date of birth, Gender, etc.
- "State if you are, or have ever been, a member of any other society or organisation administering performing rights anywhere in the world": For example if you have been a member of PRS in the UK, GEMA in Germany etc.
- "State if you propose to exclude any country from the territory in which rights are to be administered by MCSN on your behalf": By ticking "NO" here, you are stating that you want MCSN to be responsible for administering your royalties wherever your music is performed.
- Identification Type and Number: You are required to submit a copy of your valid ID card and state what kind of
 ID and the ID Number (e.g Drivers Licence, NIN, Voter's card or any other government approved identification
 type).
- Bank Account Details: MCSN will make any royalty payments you earn directly into your bank account. Input your bank details.
- Next of Kin Information: Supply the information of a close relation we can reach incase we can't reach you.

Writer Member Agreement

- Every applicant must submit a signed Writer Member Agreement before their membership application can be processed. This is a legal agreement each applicant makes with MCSN, assigning their rightS to MCSN to enable us to collect your public performance royalties on your behalf.
- The applicant's name and address should be clearly written at the top of the Member Agreement in the spaces provided.
- The Member Agreement should be dated in the space provided on the second page, and signed by the applicant.
- Please ensure your application form is signed and dated.

The Parties agree as follows:

- A. In this Deed; "Musical Work" means any musical work whether now existing or hereafter composed and, without prejudice to the generality of the expression includes:
 - any part of a musical work,
 - any vocal or instrumental music recorded on the soundtrack of any Film,
 - any musical accompaniment to non-musical plays,
 - any words or music of monologues having a musical introduction or accompaniment,
 - any other words (or part of words) which are associated with a musical work (even if the musical work itself is not in copyright, or even if the Performing Rights in the musical work are not administered by the Company).
- B. The Assignor hereby assigns to MCSN ALL the under-mentioned rights in musical works which now belong to or shall hereafter be performed by or produced by the Assignor during the continuance of the Assignor's membership of MCSN, and all such parts or shares (whether limited as to time, place, mode of enjoyment or otherwise) of, and all such interests in, any such rights as so belong to or shall so be acquired by or be or become vested in the Assignor (all which rights hereby assigned or expressed or intended to be assigned are hereinafter collectively referred to as "the rights assigned").
- C. TO HOLD the same unto MCSN for its exclusive benefit during such time as the right assigned continue to subsist and (in accordance with the provisions of the Articles of Association of MCSN for the time being in force) remain vested in or controlled by MCSN.

- the Writer shall and will so long as the Writer shall continue to be a member of the Company do, execute, and make all such acts, deeds, power of attorney, assignments to or vesting in the Company or enabling the Company to exercise and enforce the rights assigned or any part thereof as the Company may from time to time reasonably require.
